Update on Island Wildfire

Earlier this week, the Jekyll Island Fire Department and Georgia Forestry responded to a woods fire on the north end of Jekyll Island. This is the second fire in this remote location in the past week.

Due to the remote location of the fire and the fact that it poses NO DANGER to people or property, it will be handled as a control burn beginning early today, Thursday, 1/14. For the next 3 - 4 days everyone should expect conditions that normally accompany a woods fire. Please be aware that the fire is under control and is being monitored closely.

Once the area is burned off, which by all accounts should be by Friday afternoon, the smoke will linger for a few days.
